ORDER

Sri.P.V.Kunju Mathai, While working as Forest Guard in Machad Range, Elanad Forest Station, Thrissur district, was placed under suspension on 06.07.2006 as he refused to take up the charge of Secretary of Vanasamrakshna Samathi and showed arrogant behaviour towards his superior Officer that amounted to insubordination and violation of the code of conduct. He was reinstated on 05/04/2008. A punishment of withholding of one annual increment without cumulative effect was imposed on him and the period of suspension was regularised as eligible leave as per the order read as 1st paper above. His

Appeal against the punishment was rejected by the Central Circle Forest Conservator Thrissur as per the order read as 2nd paper above. Against the order, Sri.P.V.Kunju Mathai approached Principal Chief Conservator of Forest (Forest Management) and as per the order read as 3rd paper above, the PCCF upheld the punishment of barring one annual increment without cumulative effect and ordered to regularize the period of suspension as duty for the purpose of pensiononly. Against this order Sri.P.V Kunju Mathai submitted representation before Government as per the letter read as 4th paper above for regularising the period of suspension as duty for all purposes including Pay and Allowances and to disburse the consequential benefits .He filed OA (EKM) 1556/2019 before the Hon'ble Kerala Administrative Tribunal with the same prayer.

- 2) As per the judgement read as 5th paper above, the Hon'ble Kerala Administrative Tribunal (Additional Bench Ernakulam) ordered to consider the representation and pass orders after hearing the applicant as expeditiously as possible and at any rate within a period of three months from the date of receipt of the certified copy of the order, Hon'ble Tribunal directed to look into the non disbursement of DCRG also.
- 3) As such Sri. P.V.Kunju Mathai was heard in person on 07/11/2019, Government have examined the representation from the applicant and the report from the Additional Principal Conservator of Forests in detail and viewed that the behaviour of the applicant was not what was expected from the member of a disciplined force and it was beyond doubt insubordination and hence penalty was imposed on him to the effect of barring one annual increment without cumulative effect. As per the provisions in Rule 56,Part I,Kerala Service Rules, suspension period can be treated as duty for all purposes including Pay and Allowances only if he is fully exonerated of all charges. Sri.P.V Kunju Mathai's punishment of withholding one increment without cumulative effect is upheld and hence the request cannot be allowed.
- 4) In the above circumstances the representation submitted by Sri.P.V Kunju Mathai, Section Forest Officer (Rtd) is hereby rejected and Principal Chief

Forest Conservator is hereby directed to disburse the DCRG, if it is not done, at the earliest after completing all formalities and as per the existing rules and regulations. The Judgement of Hon'ble Kerala Administrative Tribunal in OA(EKM) 1556/2019 is complied with accordingly.
