ORDER

As per Para 229 of the Budget Speech 2017-18, it was announced that an amount of Rs. 105 crores (Rupees one hundred and five crores only) is sanctioned in the Special Investment Scheme for establishing a rehabilitation centre for elephants on international standards at Kottoor in Thiruvananthapuram. Financing of the project will be made through the Kerala Infrastructure Investment Fund Board (KIIFB) - a body created under the Kerala Infrastructure Investment Fund Act 1999 (amended by the Kerala Infrastructure Investment Fund Board (Amendment) Ordinance, 2016).

2) The Principal Chief Conservator of Forests (WL) & Chief Wildlife Warden as per letter read as 3rd paper above, has furnished a Concept note on the proposed "State-of-the-art Elephant Rehabilitation Centre" at Kottoor, Thiruvananthapuram to be undertaken under the KIIFB project at a total estimate of 105 crores (Rupees one hundred and five crores only). The detailed indicative/tentative project cost is as shown below.

- 4) Further, the Neyyar-Peppara Forest Development Agency is designated as the Special Purpose Vehicle (SPV) for the implementation of the project which is an existing agency registered under the Travancore-Cochin Literary, Scientific and Charitable Societies Registration Act, 1955 and the CEO of the Neyyar-Peppara Forest Development Agency is empowered to exercise the powers of the CEO of the SPV. Sanction is also accorded for conducting detailed feasibility study and preparation of the Detailed Project Report (DPR) as detailed above.
