NOTIFICATION

G. O. (Ms.) No. 1/2011/P&ARD. Dated, Thiruvananthapuram, 21st January, 2011.

S. R. O. No. 52/2011.—In exercise of the powers conferred by sub-section (8) of section 5 of the Administrative Tribunals Act, 1985 (Central Act 13 of 1985), the Government of Kerala hereby specifies,—

(i) Thiruvananthapuram as the place at which the Principal Bench and the Additional Bench I of the Kerala Administrative Tribunal shall ordinarily sit; and

(ii) Ernakulam as the place at which the Additional Bench II of the Kerala Administrative Tribunal shall ordinarily sit.

### Explanatory Note

(This does not form part of the notification, but is intended to indicate its general purport.)

On the request from the Government of Kerala, the Central Government have established the Kerala Administrative Tribunal with effect from 26th day of August, 2010 vide GSR 705 (E) dated 25th August, 2010 in the Gazette of India No. 476 dated 25th August, 2010. Further, the State Government vide G. O. (Ms.) No. 32/2010/P&ARD dated 20-9-2010 have issued orders for the constitution of two Benches at Thiruvananthapuram and one Bench at Ernakulam.

Sub-section (8) of section 5 of the Administrative Tribunals Act, 1985 empowers the State Government to specify by notification the places at which the Principal Bench and other Benches of a State Administrative Tribunal shall ordinarily sit.

Therefore, the Government have now decided to specify that the Principal Bench and Additional Bench I of the Tribunal shall ordinarily sit at Thiruvananthapuram and the Additional Bench II shall ordinarily sit at Ernakulam.

The notification is intended to achieve the above object.
