ORDER

As per the Notification, read as 3rd paper above, the post of 'Peon' was re-designated as 'Office Attendant', by amending the Special Rules for the Kerala Last Grade Service.

- 2. Accordingly, the Managing Director, Kerala Forest Development Corporation Limited (KFDC), as per the letter read as 4th paper above, furnished a proposal to amend the Revised Service Rules of KFDC, read as 1st paper above, to re-designate the post of 'Peon' as 'Office Attendant'.
- 3. Government have examined the matter in detail. In exercise of the powers conferred as per the provision under Article 40 (x) of the Articles of Association of the KFDC, Government hereby make the amendment to the Revised Service Rules, read as 1st paper above, of the KFDC, as follows:-

The word 'Peon' shall be substituted by the words 'Office Attendant', as follows:-
