ORDER

Government have framed Kerala Forest (Regulation of Sawmills and Other Wood-based Industrial Units) Rules 2021 as per G.O and S.R.O read as 1st paper above. As per Rule 26(1) of the above said Rules, Government have to constitute a State Level Committee, consisting of members as specified under Rule 26(2), for performing the functions stipulated in the said Rules. As per the letter read as 2nd paper above, the Principal Chief Conservator of Forests & Head of Forest Force requested Government to issue orders constituting the State Level Committee as per Rule 26(1),consisting of members as specified under Rule 26(2), for performing the functions stipulated in the said Rules.

2) Government have examined the matter in detail and are pleased to issue orders to constitute the State Level Committee; as prescribed under Rule 26(1) of the Kerala Forest (Regulation of Sawmills and Other Wood-based Industrial Units) Rules, 2021 with members as specified in rule 26(2) of said rules.

(a)	Principal Chief Conservator of Forests and Head of Forest Force	Chairman
(b)	Representative of the Ministry of Environment, Forest and Climate Change	Member
(c)	Representative of the State Forest Department not below the rank of a Conservator of Forests dealing with preparation of working plans / working schemes - nominated by the Principal Chief Conservator of Forest & Head of Forest Force.	Member
(d)	Director/Additional Director of the Department of Industries	Member
(e)	Representative of the Kerala Forest Development Corporation	Member
(f)	An officer not below the rank of Conservator of Forests working in the Forest Headquarters - nominated by the Principal Chief Conservator of Forest & Head of Forest Force.	Member Secretary
(g)	The State Level Committee may co-opt an officer from Territorial Wing of the Forest Department not below the rank of Conservator of Forests and Officers from Department of Agriculture and Department of Revenue.	Member

3) Government also order that the Officers from other departments are nominated by designation and the department concerned is requested to select a suitable Officer and their nomination shall be intimated to the Member Secretary of the State Level Committee then and there.
