ORDER

As per the letter read above, the Special Government Pleader, Forest Tribunal. Kozhikkode and Tribunal For Ecologically Fragile Land cases, Kozhikkode represented that the daily payment for appearance before the Forest Tribunal and Ecologically Fragile Land Tribunal amounts to a meagre one compared to the quantum of work done and requested for a considerable enhancement in the fee.

Special Government Pleaders appointed to conduct cases before the Forest Tribunal and Tribunal for EFL cases are eligible for appearance fee (per sitting)@₹250/- at the maximum and this rate was fixed in 2014. Since then the remuneration of Special Government Pleader, Senior Government Pleader, Government Pleader, District Government Pleader, Additional District Government Pleader, Advocates doing Government works in Munsiff Court, Advocates appointed to conduct cases before the MACT has been revised.

In the above circumstances, Government are pleased to enhance the rate of appearance fee of Special Government Pleader appointed to conduct Forest cases before the Forest Tribunal and Tribunal for Ecologically Fragile Land cases to ₹350/- (Rupees Three Hundred and Fifty only) per sitting.
