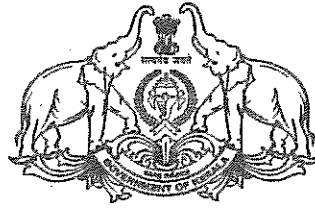

In exercise of the powers conferred by sub-section (1) of section 32 of the Protection of Children from Sexual Offences Act, 2012 (Central Act 32 of 2012) and in supersession of the notification issued under G.O.(Rt)No.495/2018/Home dated 16<sup>th</sup> February, 2018 and published as S.R.O.No.144/2018 in the Kerala Gazette Extraordinary No.623 dated 9<sup>th</sup> March, 2018, Government of Kerala hereby appoint Sri. Ajith Prasad J.K., Ajith Nivas, Kattayikkonam P.O, Thiruvananthapuram as Special Public Prosecutor in the Additional District and Sessions Court-I, Thiruvananthapuram which is specified as a Children's Court to try cases related to



Protection of Children from Sexual Offences Act, 2012 as per notification issued under G.O. (P)No.23/2015/SJD dated 31<sup>st</sup> March, 2015 and published as S.R.O.No.203/2015 in the Kerala Gazette Extraordinary No.785 dated 7<sup>th</sup> April, 2015, for a period of three years from the date on which he assumes charge as such.

### Explanatory Note

(This does not form part of the notification, but is intended to indicate its general purport.)

Sub-section (1) of section 32 of the Protection of Children from Sexual Offences Act, 2012 (Central Act 32 of 2012) provides that the State Government shall, by notification in the Official Gazette, appoint a Special Public Prosecutor for every Special Court for conducting cases under the provisions of the said Act. As per G.O.(Rt)No.495/2018/Home dated 16<sup>th</sup> February, 2018 and published as S.R.O. No.144/2018 in the Kerala Gazette Extraordinary No.623 dated 9<sup>th</sup> March, 2018, Government have appointed Smt. Valsa Varghese, S, TC 44/863, OLG Nagar, Vallakkadavu P.O, Thiruvananthapuram-695 008 as Special Public Prosecutor in the Additional District and Sessions Court-I, Thiruvananthapuram exclusively for the trial of cases under the Protection of Children from Sexual Offences Act, 2012.

Now Government have decided to appoint Sri. Ajith Prasad J.K., Ajith Nivas, Kattayikkonam P.O, Thiruvananthapuram as Special Public Prosecutor exclusively for the trial of cases under the Protection of Children from Sexual Offences Act, 2012 in the above said Court by superseding the afore mentioned notification.

The notification is intended to achieve the above object.
