In view of the decisions of the meetings (minutes read as 1st and 2nd papers above), the Executive Director, Suchitwa Mission, as per the letter read 3rd paper above, has requested to accord sanction for the work related to the preparation of Coffee Table Book on 'Project Green Grass'.

2. The Forest Department is the nodal agency for the Project Green Grass being undertaken to remove waste dumped in forest areas. The Chief Conservator of Forests (Eco-development & Tribal Welfare), as per the letter read 5th paper above, has furnished a proposal to prepare a Coffee Table Book detailing the work of the project for educational and documentation purposes. The funding of the book will be provided by Suchitwa Mission, with content and layout approval being given by the Task Force of the Green Grass Project. The Task Force (minutes read as 4th paper above) has approved the proposal and the action taken to identify a suitable agency for the same.

3. Government have examined the matter in detail and are pleased to accord sanction to the Executive Director, Suchitwa Mission, to do the work

relating to the preparation of Coffee Table Book on 'Project Green Grass' as per the specifications mentioned in the proposal and as per the terms and conditions approved for the agency selected. The Principal Chief Conservator of Forests & Head of Forest Force will provide the necessary inputs and assistance to the Suchitwa Mission and the agency chosen for the purpose of preparation of the book. The Task Force will ensure that the contents of the book is suited to the objectives and outcomes of the project. The first draft of the book should be ready by February 28th 2020 for consideration and approval by the Task Force.
