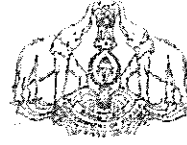

ORDER

Government vide G.O.(Rt)No.17/11/F&WLD dated, 17.01.2011, had accorded administrative sanction for the allotment of 30,000 MT of reeds p.a at free of cost to the KSBC Limited, for a period of 5 years from 01.11.2010 to 31.10.2015 for the use of Bamboo workers in the state after executing agreement with Kerala State Bamboo Corporation. And as per G.O.(Rt)184/2011/F&WLD dated, 02.05.2011, Government have approved the draft agreement with Additional Principal Chief Conservator of Forests (Protection) and Managing Director, Kerala State Bamboo Corporation Limited.

The Additional Principal Chief Conservator of Forests (Protection) vide his letter read as 3rd paper above has requested to renew the agreement between Kerala Forest Department and Kerala State Bamboo Corporation Limited w.e.f. 01.11.2015 for another period of 5 years, to be executed between the Managing Director, Kerala State Bamboo Corporation Limited and the Additional Principal Chief Conservator of Forests (Protection), Thiruvananthapuram.

Government have examined the matter in detail and are pleased to accord sanction to the Additional Principal Chief Conservator of Forests (Protection) to take necessary steps to execute the agreement with the Managing Director, M/s Kerala State Bamboo Corporation Limited for the allotment of 30,000 MT of reeds p.a at free

of cost to Kerala State Bamboo Corporation Limited for a period of 5 years from 01.11.2015 to 31.10.2020 for the use of bamboo workers in the state.
