ORDER

The Kerala Public Service Commission vide letter read as ^{2nd} above has advised Sri.Subhash.K.B, Kodithottathil House, Punchavayal.P.O,504 Colony, Mundakkayam, Kottayam for appointment as Assistant Conservator of Forests (SR for SC/ST) on Rs.13930-20250/- (PR) in the Forest Department.

2. In the notification published by the Kerala Public Service Commission for selection to the post of Assistant Conservator of Forests (SR for SC/ST) as Category No.234/2009 published in the Gazette dated 30/06/2009 with the condition to undergo a special course of study at the Forest College, Dehradun as per the Kerala Forest Service rules, 1966.

As per para 11 (a) of notification of Kerala Public Service Commission a person selected for being subsequently appointed as Assistant Conservator of Forest by Direct Recruitment shall undergo a special course of study at the Forest College. On successful completion of the course, he shall be appointed as Assistant Conservator of Forests on probation subject to the availability of vacancy.

- 3. The Director, Forest Education, Government of India vide letter read as 4th above has allotted 1 (one) seat for the two years Diploma Course in Forestry 2015-2017 State Forest Service Officers scheduled to be held at Central Academy for State Forest Service (CASFOS), Coimbatore (Tamil Nadu) with effect from 05/05/2015.
- 4. The District Medical Officer of Health, Thiruvananthapuram was requested to forward Health certificate after medical examination of the advised candidate bv the Medical Board as prescribed GO(P)No.20/2011/P&ARD dated 30/06/2011 to testify that the candidates possess sound health and general physical fitness to undertake strenuous and rough/outdoor work in the Kerala Forest Department. Accordingly, the above candidate was got examined by the Medical Board and the Medical Fitness Certificate is also furnished vide letter read as 6th paper above.
- 5. In the circumstances Government are pleased to order that Sri.Subhash.K.B, Kodithottathil House, Punchavayal.P.O, 504 Colony, Mundakkayam, Kottayam is deputed for two years Diploma Course in Forestry 2015-17 of State Forest Officers at the Central Academy for State Forest Service, Coimbatore, Tamilnadu starting from 05/05/2015 with the following conditions
 - I. The candidate is directed to report before the Principal Chief Conservator of Forest & HoFF on or before 05/05/2015.He should produce all the relevant documents and certificates in original at the time of reporting. The PCCF&Hoff should verify all the original documents.
 - II. The candidate shall execute a bond with two sureties for all sums which in any way stipended, paid or incurred by the State Government in respect of his course of study at the Central Academy, Coimbatore and also a separate agreement in such forms as may be prescribed by State Government

from time to time undertaking to serve the said Government or the Forest Department for a period of at least seven (7) years after successfully completing his training at Dehradun.

- III. After the verification by the PCCF&HoFF, the candidate is directed to report before the Director, Central Academy for State Forest Service, Coimbatore on or before 05/05/2015. He should produce all the following certificates in original at the time of reporting.
 - a. Proof of age
 - b. Bachelor's Degree
 - c. A Certificate of Physical Test (Walking) issued by the Competent Authority.
 - d. Certificate of Health issued by the Medical Board.
 - e. Appointment / Nomination letter issued by the Sponsoring Authority.
- IV. The PCCF&Hoff is instructed to remit the following amount by Bank draft in favour of the Head of Office, Central Academy for State Forest Service payable at Coimbatore, before the trainee joins the Academy on 05/05/2015.
 - a. Tuition Fees: Rs.85,000/- (Rupees Eighty Five Thousand only) per trainee for the whole course.
 - b. Expenses on Tour: Rs.1,60,000/- (Rupees One Lakh Sixty Thousand Only) per trainee (Expenses on journeys for Joining or Leaving the Academy and for Journeys during vacation are not included).
 - c. Equipment Allowance: Rs.60,000/- (Rupees sixty Thousand only) for the whole course per trainee.
 - d. Salary or minimum stipend @ Rs.33,800/- (Rupees Thirty Three Thousand Eight Hundred Only) per month i.e. the total amount of salary or stipend to the trainees should be sent in full for the entire course.
 - V. The Candidate is instructed to deposit Rs.10,000/- as Caution Money (refundable), Rs.4000/- as Mess advance (refundable) before the Central Academy at the time of joining the training course.

- VI. He will not be entitled to any pay while undergoing the course of study prescribed in Sub rule (a). During the period he will however be paid a stipend at @ Rs.33,800/- per month.
- VII. On successful completion of the course, he will report before the Government for appoint him as Assistant conservator on probation subject to availability of vacancy.
- VIII. A directly recruited Probationary Assistant Conservator will be given practical training for a period of two years from the date of his appointment as Probationary Assistant conservator. He will be paid during the period of his practical training, the pay and allowances, admissible to an Assistant Conservator and the period of this training would count for increments, leave, pension etc.
