ORDER

Government have issued orders as per Government Orders read as 1st to 3rd paper above entrusting the appointing authorities to obtain Police Verification as well as P. S. C. Verification Report for regularization of all appointments made through the Kerala Public Service Commission in future. It was also ordered that separate orders shall be issued extending the applicability of the provisions in the Government Order read as 2nd and 3rd paper above to the Last Grade Servants, by effecting necessary amendment to the relevant rules.

2. Government have examined the matter further in detail and are pleased to order that Police Verification Report and P. S. C. Verification Report in the case of persons appointed through Kerala Public Service Commission along with the other provisions as mentioned in the Government Orders read above be made mandatory for regularization of all appointments made to the Last Grade Service as well.

3. Necessary amendment with regard to Police Verification shall be made in the Kerala Last Grade Service Special Rules, 1966.

4. The Home Department shall make necessary amendment regarding Police Verification in the provisions in G. O. (P) 112/2006/Home dated 31-7-2006.
