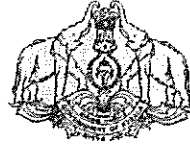

Government have examined the matter in detail and order to constitute an Expert Committee with the following officers to review the matter of revision of FSR for weeding operations and for making necessary recommendations.


