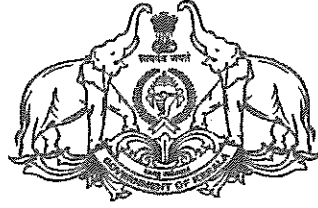

In exercise of the powers conferred by sub-section (1) section 32 of the Protection of Children from Sexual Offences Act, 2012 (Central Act 32 of 2012), and all other powers enabling it in this behalf, the Government of Kerala hereby appoint the Special Public Prosecutor in column (2) in the Fast Track Special Court mentioned against in column (3) sanctioned for the speedy disposal of rape cases and cases registered under Protection of Children from Sexual Offences Act, 2012 (Central Act 32 of 2012) as per notification issued under G.O.(Ms.)No.211/2020/Home dated 5th November, 2020 and published as



S.R.O.No.780/2020 in the Kerala Gazette Extraordinary No.2655 dated 5th November, 2020, for a period of two years with effect from the date on which he assume charge as such.

Explanatory Note

(This does not form part of the notification, but is intended to indicate its general purport.)

Sub-section (1) of section 32 of the Protection of Children from Sexual Offences Act, 2012 (Central Act 32 of 2012) provides that the State Government shall, by notification in the Official Gazette, appoint a Special Public Prosecutor for every Special Court for conducting cases under the provisions of the said Act. Government as per G.O.(Ms.)No.93/2020/Home dated 24th April, 2020 have accorded sanction to establish 28 Fast Track Special Courts (FTSCs) in 14 districts for the speedy disposal of rape cases and cases registered under Protection of Children from Sexual Offences Act, 2012 (Central Act 32 of 2012) in the State on temporary basis for a period of two years out of which one Fast Track Special Courts was established at Punalur as per G.O.(Ms.)No.211/2020/Home dated 5th November, 2020 and published as S.R.O.No.780/2020 in the Kerala Gazette Extraordinary No.2655 dated 5th, November, 2020.

Government considers it necessary to appoint Special Public Prosecutors, who are having the requisite qualification to be appointed as Special Public Prosecutor in the Fast Track Special Courts for the conduct of rape cases and cases under the Protection of Children from Sexual Offences Act, 2012 (Central Act 32 of 2012). The appointment shall be subject to the result of Writ Petitions/Writ Appeals, if any, pending before any court of law in this regard.

The notification is intended to achieve the above object.
