ORDER

In continuation of the Government Order read as 1<sup>st</sup> paper above and in the circumstances reported and as requested by the Principal Chief Conservator of Forests (Development & PFM) in the letter read as 2<sup>nd</sup> above Sanction is accorded for the collection of Minor Forest Produce (MFP) to 20 Scheduled Tribe Co-operative Societies (list appended to this Government Order) who have collected MFP successfully during 2012-2013, till 31.03.2014 or till the date of coming into effect of community right on MFP under Forest Right Act 2006 whichever is earlier under the condition that the allotment of any Range/particular area shall stand cancelled once the community right of tribals is recognized in that range or particular area.
