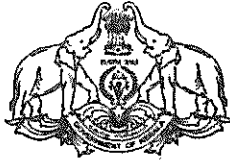

S. R. O. No. 717/2016.—In exercise of the powers conferred by clauses (2) and (3) of article 166 of the Constitution of India, the Governor of Kerala hereby makes the following rules further to amend the Rules of Business of the Government of Kerala, namely:—

PRINTED AND PUBLISHED BY THE SUPERINTENDENT OF GOVERNMENT PRESSES
AT THE GOVERNMENT CENTRAL PRESS, THIRUVANANTHAPURAM, 2016.

RULES

1. *Short title and commencement.*—(1) These rules may be called the Rules of Business of the Government of Kerala (Amendment) Rules, 2016.

(2) They shall come into force at once.

2. *Amendment of the Rules.*—In the Rules of Business of the Government of Kerala, in PART II, in the FIRST SCHEDULE,—

(i) under the heading “List of Departments”, for the entry against serial number 3, “Backward Community Development Department”, the following entry shall be substituted, namely:—

“Backward Classes Development Department”;

(2) under the heading “DISTRIBUTION OF BUSINESS AMONG DEPARTMENTS OF THE SECRETARIAT”, for the sub-heading “III. BACKWARD COMMUNITIES DEVELOPMENT DEPARTMENT”, the following shall be substituted, namely:—

“III. BACKWARD CLASSES DEVELOPMENT DEPARTMENT”.

Explanatory Note

(This does not form part of the notification, but is intended to indicate its general purport.)

As per G. O. (Ms.) No. 59/2012/GAD dated 19th March, 2012 orders were issued for the formation of Backward Communities Development Department and necessary amendments to the Rules of

Business of the Government of Kerala were issued as per the Notification G. O. (Ms.) No. 151/2012/GAD dated 14th June, 2012 and published as S.R.O. No. 455/2012 in the Kerala Gazette Extraordinary No. 1306 dated 19th June, 2012. The commission and corporation under the administration of the said department are Kerala State Commission for Backward Classes and Backward Classes Development Corporation Ltd. Hence the Government have decided to change the name of the said department as Backward Classes Development Department. Accordingly, necessary amendments are to be made in the Rules of Business of the Government of Kerala.

The notification is intended to achieve the above object.
