ORDER

As per Government Order read as 2nd paper above, Government have ordered to market timber and other forest produce through online by utilizing the services of M/s. MSTC Ltd, Kolkata. As per the Government order read as 3rd paper above, permission was accorded to continue the present system of e-auction for a further period of one year from 29.03.2018 and the period expired on 28.03.2019.

2) The M.S.T.C, Ltd; vide letter read as 1st paper above requested the Principal Chief Conservator of Forests (Forest Land & Resources) for renewal of the Selling Agency Agreement as the agreement expired on 28/03/2019.

3) As per the letter read as fourth paper above, the Additional Principal Chief Conservator of Forests (Forests, Land & Resources) has requested to permit the Kerala Forest Department to avail the service of M/s. MSTC Ltd for e-auction by paying 0.8% service charges for a further period of three years from 29.03.2019 and to renew the Selling Agency Agreement.

4) Government have examined the matter in detail and are pleased to grant permission to avail the services of M/s. MSTC Ltd; for one more year from 29.03.2019, by paying 0.8% service charge to undertake e-auction platform for the sale of timber in the Kerala Forest Department by renewing the Selling Agency Agreement with M.S.T.C Ltd.
