## ORDER

Exhibition of *Vanasree* products and other craft materials, seminars and symposia on topical subjects, cultural programmes etc. are also proposed as part of the 'Sangamom'. The 'Sangamom' will be arranged in Kanakakunnu Palace, Sooryakanthi Exhibition ground, Sooryakanthi fair ground and Nishagandhi Auditorium. The 'Sangamom'will provide a platform to Forest Department and all other allied Institutions and Agencies in the field of Medicinal Plants and Ayurvedic Medicines, Ecotourism, Plantation Sector, Environment, Biodiversity, Research Institutes etc. to showcase their role and achievements in relation to activities done to improve the livelihood and well-being of the forest dependent communities.
- (3) Government have examined the proposal in detail and are pleased to accord permissive sanction to conduct "Kanana Sangamom, 2015" at Kanakakkunnu Palace Ground from 18<sup>th</sup> April to 22<sup>nd</sup> April, 2015 and to seek participation of other departments and Public Sector Undertakings for sponsoring the event.
