ORDER

As per the enquiry report read as first paper above, the Director, Vigilance and Anti-corruption Bureau, recommended departmental action against the officers responsible for the missing of seized timber of various OR cases in 5 sections of Kumili Range (Vandanmettu, Chellarkovil, Chinnar, Kallar, Cumbummettu).

2) Government had issued Show Cause Notice to N.A.Sathyanandan, one among the 39 forest officials involved in this case, as per letter read as 2nd paper above and provisionally decided to recover an amount of Rs.1250/- being the proportionate amount of the loss sustained to Government from his monthly pension in equal instalments under Rule 3 Part III Kerala Service Rules.

3) As per the letter read as 3rd paper above, Additional Principal Chief Conservator of Forest (Administration) has informed that, N.A.Sathyanandan, Section Forest Officer (Rtd) has expired and hence requested to drop all the further action against him on compassionate ground.

4) Government have examined this case in detail and by accepting the request of Additional Principal Chief Conservator of Forest (Administration), orders to drop the disciplinary action against N.A.Sathyanandan, Section Forest Officer (Rtd).
