The estimated expenditure during current year is Rs. 25 crore under Forest Department. Financing of the project will be arranged by the Kerala Infrastructure Investment Fund Board (KIIFB) - a body created under the Kerala Infrastructure Investment Fund Act 1999 (amended by the Keala Infrastructure Investment Fund Board '(Amendment) Ordinance, 2016).

Principal Chief Conservator of Forests (FM) as per letter read as 4th paper above has furnished Detailed Project Report on fencing along Forest boundary under the special investment Plan, prepared by the Principal Chief Conservator of Forests (WL) & Chief Wildlife Warden at a total estimate of Rs.100.00 Crore, (Rupees One Hundred Crore only) with KIIFB assistance. The detailed project on the works to be carried out during the current financial year for Rs.25.00 crore (Rupees Twenty Five Crore only) is incorporated as Phase I for fencing along the forest boundary as shown below.
