ORDER

The Principal Chief Conservator of Forests (Social Forestry) as per the letter read as first paper above has forwarded a detailed project proposal to implement 'Haritha Nagaram' programme at Kottayam through the beautification of MC Road from Kodimatha to Kottayam and has informed that the total expenditure in this regard comes to the tune of Rs. 27,86,000/- as reported to be met from the head of account 2406-01-800-55-01-Extension Forestry.

Government in its Working Group Meeting held on 11.3.2015 discussed the proposal in detail and have decided to rename the project as 'Haritha Nagaram' scheme for beautification of Kottayam Muncipal Area after eliminating the components listed from 11-16 of Annexure III of the proposal which are not related to Social Forestry, subject to the following conditions.

- 1) The period of the Scheme shall be limited to 3 years.
- 2) Only forest tree species will be planted using plan fund. By excluding expenditure for items 11-16 first year expenditure will be limited to Rs.10,20,000/-. However Rs.1 lakh shall be used for watering the garden during summer season.
- 3) Fencing/tree guards to be done with Bamboo & Reeds.
- 4) The components which are not related to (Social Forestry) should be avoided.

The modified components were details are appended herewith.
