**Applications invited for appointment as Chairperson of the
Kerala State Commission for Protection of Child Rights.**

Applications are invited from qualified candidates for appointment as **“Chairperson of the Kerala State Commission for Protection of Child Rights”** as per the Kerala State Commission for Protection of Child Rights Rules, 2012 notified as S.R.O No.700/2012 dated 4th October 2012 and S.R.O No.161/2015 dated 6th March, 2015.

I. Number of Vacancy: 1 (One)

II. Qualifications:

(1) Candidates who have done outstanding work for promoting the welfare of children and his/her work in promoting the welfare of children has earned him/her one or more distinctions/awards at the State/National/International levels conferred by the State Government/Central Government or other recognized International bodies with documentary evidence to substantiate such claim of outstanding contribution.

OR

Candidates who have done outstanding work for promoting the welfare of children and is holding /has held a position that is of or above the rank of Secretary to Government. [For this purpose the Warrant of Precedence prescribed by the State Government shall be adopted to determine whether the post held is over and above the rank of Secretary to Government]

(2) He/She should not have any past record of violation of human rights or child rights.

(3) He/She should not have been convicted and sentenced for imprisonment of an offence which in the opinion of the Government involves moral turpitude.

(4) He/She should not have been removed or dismissed from service of the Central Government or a State Government or a body or Corporation owned or controlled by the Central Government or a State Government.

(5) He/She shall not be a Member of Parliament or be a Member of Legislature of any State or shall not hold any office of trust or profit. In case he/she carries on any business or practices any profession, he/she shall suspend as the case may be such business or practice before he/she assumes his office, if selected for appointment.

(6) Age: Must have completed 35 years and must not have completed Sixty five (65) years as on 01.01.2017.

III. Term of appointment:

The term of appointment of the Chairperson will be three (3) years from the date of assumption of charge but not beyond 65 years of age.

IV. Remuneration:

Chairperson will be eligible for a fixed honorarium as allowance as fixed by Government. In the case of State Government/Central Government employees their salary will be regulated in accordance with the rules applicable to them and in the case of retired Government employees salary will be regulated as per the Rule 100, Part III, KSRs.
