S. R. O. No. 622/2017.—In exercise of the powers conferred by clauses (2) and (3) of Article 166 of the Constitution of India, the Governor of Kerala hereby makes the following rules further to amend the Rules of Business of the Government of Kerala, namely:—

RULES

1. *Short title and commencement.*—(1) These rules may be called the Rules of Business of the Government of Kerala (Amendment) Rules, 2017.

(2) They shall come into force at once.

2. *Amendment of the Rules.*—In the Rules of Business of the Government of Kerala, in Part II, in the FIRST SCHEDULE, under the heading ‘DISTRIBUTION OF BUSINESS AMONG DEPARTMENTS OF THE SECRETARIAT’, under the sub-heading ‘XXIV, LOCAL SELF GOVERNMENT DEPARTMENT’, under the item ‘A. Urban Development and Panchayats’, after serial number 17 and the entry against it, the following serial number and entry shall, respectively, be inserted, namely:—

“18. Administration of the Real Estate (Regulation and Development) Act, 2016 (Central Act 16 of 2016)”.

Explanatory Note

(This does not form part of the notification, but is intended to indicate its general purport.)

As per G. O. (Ms.) No. 13/2017/Hsg. dated 23rd May, 2017, the Government have accorded sanction for including the subject “Administration of the Real Estate (Regulation and Development) Act, 2016 (Central Act 16 of 2016)” under the subjects allotted to the Local Self Government Department. Accordingly, the Government have decided to make necessary amendment in the Rules of Business of the Government of Kerala for the said purpose.

The notification is intended to achieve the above object.
