ORDER

As per Government Order read as 1st paper above, administrative sanction was accorded to take up the Project proposal for Mitigation of Man-animal Conflict in Wayanad District by erecting Solar Powered Fencing under NABARD RIDF XVII with the loan assistance of Rs.5.74 crores.

- (2) The work was entrusted to Kerala Forest Development Corporation based on the MoU executed between the Department and the Corporation. But the Kerala Forest Development Corporation could'nt complete the entire work within the time.
- (3) In the meeting convened by the Additional Chief Secretary, Forest & Wild Life Department on 07.10.2014, it was decided to wind-up the work done so far by Kerala Forest Development Corporation. It was further decided that the Additional Principal Chief Conservator of Forests (NR) will undertake the execution of the remaining works through Forest Development Agencies and the Principal Chief Conservator of Forests (D&PFM) will furnish proposal for mobilization of 20% of the total project cost for executing the remaining portion of the project.
- (4) Accordingly the Principal Chief Conservator of Forests (D&PFM) vide the letter read as 3rd 4th papers above has furnished proposal for the release of 20% of the total cost of the project (of Rs.5.74 crores) as mobilization advance.

(5) Government have examined the matter in detail and are pleased to accord sanction to undertake the remaining work of erecting Solar Powered fencing in Wayanad District (RIDF XVII Project) through the help of Forest Development Agencies and for the release of Rs.1.14 crore, being 20% of the project cost as mobilization advance to the Department in two equal installments, for the NABARD RIDF XVII project "Construction of Solar Powered Fencing to Mitigate Man-animal Conflict" in Wayanad District, subject to the condition that the mobilization advance will be recovered in subsequent Letter of Credit proposals.
