ORDER

As per Government Order read as 1st paper above, Administrative Sanction was accorded for the procurement of 107 Nos. of Global Positioning System (GPS) at a total cost of Rs. in Rs.15,37,862/- (Rupees Fifteen Lakh Thirty Seven Thousand Eight Hundred and Sixty Two only) from M/s Solar Spectrum Energy Systems, Mumbai, for implementing the project 'Forest Management Information System and Geographical Information System' by meeting the expenditure from the head of account 2406-01-800-57 (Plan).

2) Now Principal Chief Conservator of Forests (D & PFM) vide letter read as 2nd paper above, has submitted a proposal to give revised Administrative Sanction for the procurement of GAGAN enabled GPS.

3) The Departmental Working Group Meeting held on 03/12/2015, considered the proposal of Principal Chief Conservator of Forests (D&PFM) and agreed to give revised Administrative Sanction for the procurement of 21 Nos. of GAGAN enabled GPS @ Rs.75000/- for a total cost of Rs.15.75/- lakhs under the budget head 2406-01-

800-57 (Plan), on condition that purchase of GAGAN enabled GPS is only through e-tender, after cancelling the purchase sanction issued vide Government Order read as 1st paper above.

4) Based on the decision taken in the Departmental Working Group, Government are pleased to accord revised Administrative Sanction for the procurement of 21 Nos. of GAGAN enabled GPS @ Rs.75000/- for a total cost of Rs.15.75/- lakhs (Rupees Fifteen Lakh and Seventy Five Thousand only) under the Budget Head 2406-01-800-57 (Plan) on condition that purchase of GAGAN enabled GPS is only through e-tender. The purchase sanction issued vide Government Order read as 1st paper above stands cancelled.
