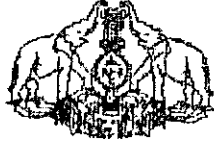

NOTIFICATION

Applications are invited from the heads of leading private medical institutions in Kerala , which satisfy the criteria appended to this notification for considering to empanel them for the treatment of the Government Employees and their dependents for sanctioning Medical Reimbursement claims as per the conditions stipulated in the KGSMA Rule 1960.

2) The following shall also be satisfied:

1. Hospitals should have sufficient buildings and infrastructure.
2. Hospitals should have sufficient equipments and O.T.facilities.
3. Hospitals should have sufficient manpower and charitable activities.
4. Audit reports of the Chartered Accountant for the last 3 years should be furnished.
5. Hospitals should have sufficient facilities equivalent to that of facilities available in Government Hospitals or in Medical College Hospitals.

3)The applications shall be submitted with the filled up criteria form appended, with the recommendation of the Managing Committee, in the name of Managing Director of the institution.

4) The applications should reach Government in H&FW Department addressing the Special Secretary on or before 30.09.2011.
