As per Government Order read as 2nd paper above Government have designated Kerala State Suchitwa Mission (KSSM) as the Nodal Agency for the implementation of World Bank assisted Kerala Urban Service Delivery Project (KUSDP). As per Government Order read as 3rd paper above the name of the Project i.e. KUSDP has been changed as Kerala

- 2. As per Government Order read as 4 th paper above Government have constituted a State Project Management Unit (SPMU) for KSWMP, with following composition.

- 3. The total project cost of KSWMP is 300 million US Dollar and funding pattern for the project is as follows.
- World Bank share is 105 million US Dollar
- Asian Infrastructure Investment Bank share is 105 million US Dollar.
- State share is 90 million US Dollar.

The Project Director, KSWMP has reported that establishment expenses of the project is fully funded by World Bank and Asian Infrastructure Investment Bank.

full time Deputy Project Director in the State Project Management Unit(SPMU) of Kerala Solid Waste Management Project(KSWMP). Project Director, KSWMP has submitted a proposal to appoint Sri.U.V.Jose IAS (Rtd.) who recently retired as Special Secretary, Local Self Government Department, as Deputy Project Director in the SPMU of KSWMP as per the terms and conditions applicable to employees on re-employment.

- 7. When circulated the file to Hon'ble Chief Minister through the Minister for LSGD, the Hon'ble Chief Minister has ordered to place the matter before the Council of Ministers for decision

As per the report received from Director, Vigilance Anti-corruption Bureau vide letter No. NOC-22214/2021/DVACB dated 31.08.2021 no Vigilance Case / Vigilance Enquiry is pending against Shri U.V.Jose. Vigilance Department has informed that there is no need for a vigilance inquiry into the matter as there are no prima facie findings against the former Kottayam District Collector in the confidential report on the illegal land reclamation complaint.
- 9. As per G.O(Ms) No.152/2020/LSGD dated.09/10/2020, Government have constituted a committee under the chairmanship of Principal Secretary (Urban), for the recruitment of Experts in Project Management Unit (PMU).
