## **ORDER**

Administrative sanction was accorded for the work of Functional Household Tap Connection (FHTC) by augmenting or retrofitting the existing water supply schemes and laying new rider line in Thiruvankulam zone in Thripunithura Municipality for a sum of ₹.12.29 Crore as per Government Order read as  $1^{st}$  paper above, .

2. Technical Sanction was accorded by Kerala Water Authority for an amount of Rs 5.38 Crore. Since no offer was received, the tender was cancelled. Re-tender was invited by Superintending Engineer, PH Circle Kochi with TPAC of ₹ 4,16,96,939.92/- and the single offer was received from Sri. K.K. Ramesan, Kalarickal House, Eroor West P.O. Thrippunithura. The quoted amount of this single bidder is Rs.5,03,97,421.32 which is 20.87 % above Tendered PAC of Rs. 4,16,96,939.92/-

3. Kerala Water Authority negotiated with the contractor and they agreed to execute the work at Rs. 4,88,27,611.00/- (which was 17.10 % above TPAC).

The tender evaluation details are as follows:

a. Quoted Amount of L1 : Rs. 5,03,97,421.32/- (20.87 % above TPAC)
b.Negotiated Quoted amount : Rs. 4,88,27,611.00/- (17.10 % above TPAC)
c.LMR corresponding to TPAC : Rs. 4,62,02,298.38/- (10.81 % above TPAC);
LMR (Place: Kanayannur & Aluva & Paravur Taluk, LMR as on :13-09-2023)
e.Current SoR+10%: Rs.4,58,66,633.91 (10% above TPAC)

4. As per letter read as 2<sup>nd</sup> paper above, the Managing Director, Kerala Water Authority has requested to sanction the tender for the work Functional Household Tap Connection (FHTC) by augmenting or retrofitting the existing water supply schemes and laying new rider line in Thiruvankulam zone in Thripunithura Municipality considering that the work comes under the mission mode project AMRUT 2.0.

5. Government have examined the matter in detail. AMRUT is a central assistance scheme. Central assistance will be lost if the works are not completed on time.

6. In the above circumstances, sanction is hereby accorded to the Kerala Water Authority to award the work providing Functional Household Tap Connection (FHTC) by augmenting or retrofitting the existing Water Supply Scheme and laying new rider line to Thripunithura Municipality in Ernakulam District under Mission mode project AMRUT 2.0 to the single bidder for an amount of **Rs.4,88,27,611.00/- which is 17.1 % above TPAC.**

#### **NOTE FOR COUNCIL OF MINISTERS**

This note relates to the approval of work for providing Functional Household Tap Connection (FHTC) by augmenting or retrofitting the existing Water Supply Scheme and laying new rider line to Thripunithura Municipality in Ernakulam District under AMRUT 2.0 to the single bidder for an amount of Rs.4,88,27,611.00/-*which is 17.1 % above TPAC* 

2. As per GO (Rt) No. 2906/2022/LSGD dated 24/11/2022 Administrative sanction was accorded for the work of FHTC by augmenting or retrofitting the existing water supply schemes and laying new rider line in Thiruvankulam zone in Thripunithura Municipality for Rs.12.29 crore. Technical Sanction was accorded by Kerala Water Authority for an amount of Rs 5.38 crore as per order dated 13.06.2023. Since no offer was received, the tender was cancelled Retender was invited by Superintending Engineer, PH Circle Kochi with TPAC of  $\mathbf{R}$ 4,16,96,939.92/- and the single offer was received from Sri. K.K. Ramesan, Kalarickal House, Eroor West P.O, Thrippunithura. The quoted amount of this single bidder is Rs.5,03,97,421.32 which is 20.87 % above Tendered PAC of Rs. 4,16,96,939.92/-

3. Kerala Water Authority negotiated with the contractor and they agreed to execute the work at Rs. 4,88,27,611.00/- (which was 17.10 % above TPAC).

The tender evaluvation details are as follows:

a) Quoted Amount of L1 : Rs. 5,03,97,421.32/- (20.87 % above TPAC)

b) Negotiated Quoted amount : Rs. 4,88,27,611.00/- (17.10 % above TPAC)

c) LMR corresponding to TPAC : Rs. 4,62,02,298.38/- (10.81 % above TPAC) LMR (Place: Kanayannur & Aluva & Paravur Taluk, LMR as on :13-09-2023)

d) Current SoR + 10% : Rs. 4,58,66,633.91 (10 % above TPAC)

4. As per the prevailing Government orders, the tender can be sanctioned to the lowest among above, which is Current SoR+10%, that is Rs. 4,58,66,633.91. Kerala Water Authority reported that only a single tenderer participated in the third tender call and the negotiated amount of L1 bidder is Rs. 4,88,27,611.00/- (17.10 % above TPAC) and it is 10% above compared with current SOR+10%. The bidder is not ready to reduce his negotiated quoted rate.

5. The Joint Managing Director, Kerala Water Authority has requested to sanction the tender for the work considering that the work comes under the mission mode project AMRUT 2.0.

6. When the file was forwarded to Finance department, that department remarked as follows:

"AD is informed that the L1 received in the third call is beyond the admissible limits prescribed as per GO(P)No.16/2017/Fin dated 06/02/2017. As per para 4(v) of the G.O, if L1 received is above the approved amount even after re-tendering, the estimate should be reworked and revised estimate shall be prepared taking into account of the special physical conditions of the area where the work is being executed and re-tender shall be initiated based on the revised estimate.

Therefore, AD is requested to follow para 4(v) of G.O(P)No.16/2017/Fin dated 06/02/2017 and recast the estimate as per actual site conditions and re-tender the work with wide publicity".

7. When the file was submitted to Hon'ble Minister for Water Resources, Hon'ble Minister, observed as follows;

PRICE Software-ൽ പ്രത്യേകിച്ച് പൈപ്പകളടെയും സ്പെഷ്യലുകളടെയും കാര്യത്തിൽ മാർക്കറ്റ് നിരക്കല്ല

കാണിച്ചിട്ടുള്ളത് എന്നതിനാലാണ് ഈ അന്തരം വരുന്നത്. പ്രവൃത്തിയുടെ അടിയന്തിര . ആവശ്യം കണക്കിലെടുത്തും റി-ടെണ്ടർ കഴിഞ്ഞതായതുകൊണ്ടും ഇക്കാര്യം മന്ത്രിസഭയിൽ വയ്കാൻ ബഹു. മുഖ്യമന്ത്രി ഉത്തരവായാലും".

8. When the file was circulated to Hon'ble Chief Minister through Hon'ble Minister for Water Resourses, it is ordered to place the matter before cabinet for approval.

#### Point for decision

Over ruling the advice of Finance Department, whether the work for providing Functional Household Tap Connection (FHTC) by augmenting or retrofitting the existing Water Supply Scheme and laying new rider line to Thripunithura Municipality in Ernakulam District under Mission mode project AMRUT 2.0 may be permitted to Kerala Water Authority to award the single bidder for an amount of Rs.4,88,27,611.00/- which is 17.1 % above TPAC.
