Pramod P P IFS for granting permission to continue in the old pension scheme by reckoning his prior service from 13.11.2002 to 31.07.2006 in State Administrative Secretariat prior to his appointment in Indian Forest Service.
- 3) Government have examined the matter in detail and are pleased to allow Sri. Pramod P P IFS (KL:2006) to continue in the Old Pension Scheme (OPS) under CCS (Pension) Rules, 1972 as per Government of India instruction read as 1st paper above.
