#### **ORDER**

- i. The entire expenses for the programme such as fees, living expenses, flight travel etc. will be fully funded by the Foreign Commonwealth and Development Office (FCDO).
- ii. The officer is advised to use his personal details, rather than official one (Phone number, email ID ctc.) during the training.
- iii. The officer is instructed not to reveal his charter of duties and be cautious

- during interactions with faculty as well as fellow trainees.
- iv. The officer shall submit a detailed report after completion of the training/course. The report may contain details of faculty/guest faculty, fellow trainees, training syllabi, queries made during the training and engagement on the side-lines like interactions with think-tanks, visits, etc.
- v. Prior permission shall be obtained to attend annual Chevening Alumni Meet, if any organizing by the British High Commission in future and he shall submit a detailed report on the nature of interaction for a better understanding of Mission's motives.
- vi. Any attempt by the British High Commission/Foreign national for any informal meeting or seeking information bypassing official channels should be discouraged and may be reported to senior formation.
- vii. Necessary FCRA and Political Clearance shall be obtained.
