ORDER

The Hon'ble Kerala Administrative Tribunal as per Final Order read as (4) paper above, had disposed off the Original Application OA (EKM)No. 202/2019 filed by Sri. Jose Mathew & Sri Mohammed Basheer P with a direction to the Ist respondent ie Secretary, Higher Education Department, to pass orders on Annexure A7 & Annexure A8 representations read as (2) & (3) paper above respectively, within a period of two months from the date of receipt of a copy of said order.

Sri.Jose Mathew entered in Higher Education Department as Librarian Grade IV in the year 1989. After getting promotions of Grade III, Grade II, Grade I, he retired from service as Librarian Grade I on 30.11.2013 from Govt.Engineering College, Sreekrishnapuram,

Palakkad. Sri.Muhammed Basheer entered in Higher Education Department as Librarian Grade IV in the year 1991. He promoted to Grade III , II respectively and retired from service as Librarian Grade II on 30.10.2012 from Govt.Engineering College, Calicut.

The above mentioned petitioners in their Annexure A7 & Annexure A8 read as (2) & (3) paper above respectively, wherein the applicants pointed out that they were entitled for promotion to the post of Scientific Information Officer & Senior Grade Librarian. The delay in implementation of Committee report by way of the Government Order read as 1st paper above, had caused delay in re - fixation of post and salary w.e.f Nov' 2010. The Scale of Pay of Scientific Information Officer is Rs 29180-43640 (pre revised). The petitioners were constrained to retire in lesser scale of pay of Librarian Grade I (21240-37040 pre - revised) which caused heavy monetary loss. The applicants submit that they are entitled for promotional avenues as per new scheme including arrears of service benefits. Hence, they requested to issue appropriate orders to revise their pensionary benefits granted to them w.e.f December 2013 in the proposed newly created supernumerary post with fixed scale of pay of Scientific Information Officer and sanction respective pensionary benefits along with arrears in interest.

Government have considered the matter in detail and are pleased to reject the request made by Sri. Jose Mathew & Sri Mohammed Basheer P in their representations read as (2) & (3) paper above respectively.

The direction in the Final Order by Hon'ble Kerala Administrative Tribunal in OA (EKM)No. 202/2019 filed by Sri. Jose Mathew & Sri Mohammed Basheer P, read as (4) paper above, is hereby complied.
