ORDER

State Police Chief as per the letter read as Ist paper above has reported that Sri. Sanal Kumar G.S., DySP (Rtd) has submitted a representation, requesting to sanction Ratio Based Higher Grade

(RBHG) to him with effect from the date from which his immediate junior was sanctioned ratio based higher grade.

- 2)Sri. Sanal Kumar G.S. was promoted to the cadre of DySP vide Government order read as ^{3rd} paper above and he took charge of the post of DySP on 20.04.2011 FN. His probation was not declared in the cadre of Deputy Superintendent of Police since the following Oral Enquiries were pending against him.
- 1. Placed under suspension and Oral Enquiry was ordered against him vide Government order read as 4th paper above. The alleged charge was that while working in Pathanamthitta PS, he has not conducted proper enquiry in a petition and registered a false case against the complainant and his relatives as Cr No. 307/2005 u/s 447, 323, 308, 295 A r/w 34 IPC and submitted charge sheet to the Hon'ble Court. Later, on the petition filed by the Complainant Sri. Aji Thomas before the Hon'ble Lok Ayukta has directed to suspend Sri. G.S. Sanal Kumar from service and to initiate appropriate departmental proceedings against him. As such, he was placed under suspension and an Oral Enquiry was ordered against him. Later, , Sri. G.S. Sanal Kumar was re-instated into service vide Government order read as 5th paper above. The Oral Enquiry was disposed of by awarding with a punishment of Increment Bar for two years without cumulative effect vide Government order read as 6th paper above.
- 2. Another OE was pending against, Sri. G.S. Sanal Kumar vide Government order read as 7th paper above for the alleged charge that Sri. Sanal Kumar while working as SHO, Pathanamthitta PS, a CD file in connection with a case in Crime no. 192/2002 was handed over to him for completing the investigation. But he has not conducted proper investigation and the CD file was kept idle during the period from

10.03.2004 to 07.08.2006 leading to grave dereliction of duty. The OE was later dropped by the Government vide Government order read as 8th paper above.

Sri. Sanal Kumar G.S., DySP was not sanctioned the Higher Grade on account of non declaration of probation in the cadre of DySP and his juniors were granted Higher Grade on their turn. He retired from service on 28.02.2020. Later his probation in the cadre of DySP was declared w.e.f. 21.02.2014 vide Government order read as 9th paper above.

Sri. Sanal Kumar G.S. is placed at Sl No. 594 in the seniority list of Deputy Superintendent of Police published by the Government as per Government order read as 10th paper above. Sri. Harischandra Naik (Sl No. 593) is the immediate senior of Sri. Sanal Kumar G.S. and Sri. A. Santhosh Kumar, DySP (Sl NO. 595) is the immediate junior of Sri. Sanal Kumar G.S. But Sri. A. Santhosh Kumar was also not sanctioned RBHG due to the non declaration of probation. The next junior Sri. K.K. Raveendran had retired before becoming eligible for RBHG. Sri. Bijo Alexander (Sl No. 597), the next junior to Sanal Kumar G.S., was sanctioned Ratio Based Higher Grade with effect from 03.06.2019 vide Government order read as 11th paper above.

3)Government have examined the matter in detail and pleased to sanction notional promotion to Sri. Sanal Kumar G.S., DySP (Rtd) to the post of Deputy Superintendent of Police (Higher Grade) with effect from 03.06.2019, i.e., the date on which his immediate junior, Sri. Bijo Alexander was sanctioned Ratio Based Higher Grade subject to condition that he shall not be eligible for back arrears of pay and allowances since back arrears of pay and allowances are not admissible for notional promotions as per Rule 23(c) of Part I, KSRs. But his

pensionery benefits will be refixed based on the notional promotion.
