ORDER

As per the letter read as 1st paper above, the Hon'ble Minister for Welfare of Scheduled Castes, Scheduled Tribes and Backward Classes, Devaswoms had requested to prepare the estimate for the subject work of drawing of street main under Chelakkara Grama Panchayat and to issue Administrative Sanction under the budget for the year 2023-24.

- (2). As per the letter read as 2nd paper above, the Director, (Distribution, Safety, SCM&IT), O/o KSEBL has prepared and submitted an estimate amounting to Rs.1,49,94,024/- (Rupees One Crore Forty nine lakh Ninety four thousand and twenty four only) for the work.
- (3). As per the Government Order read as 3rd paper above, Government issued Administrative Sanction via e-anumathi application for the work of drawing of street main under Chelakkara

Gramapanchayath at total estimate cost of Rs.1,49,94,024/- (Rupees One Crore Forty Nine Lakh Ninety Four Thousand and Twenty Four only) and meeting the expenditure for the work from the functional head of Power Department, that is from the provision under the head of account 4801-80-101-98-00-00-0-N-V.

- (4). As there is no head of account available for drawing of Street Main under Chelakkara Grama panchayath, as per Government Order read as 4th paper above, a new head of account "4801-80-800-97-03-Drawing of Street Main under Chelakkara Gramapanchayath" has been opened for the work and a temporary provision of Rs.1,49,94,024/- has also been provided in the e-Anumathi application for issuing revised Administrative Sanction for this work.
- (5). Government have examined the matter and are pleased to issue revised Administrative Sanction via e-anumathi application for the work of drawing of street main under Chelakkara Gramapanchayath at total estimate cost of Rs.1,49,94,024/- (Rupees One Crore Forty Nine Lakh Ninety Four Thousand and Twenty Four only) and meeting the expenditure from the new head of account "4801-80-800-97-03-Drawing of Street Main under Chelakkara Gramapanchayath as per details given below:
