**ORDER**

An amount of Rs.917 Lakh has been provided in the budget under the Head of Account 2810-00-800-90-(08)-35-00 and an amount of Rs.92.00 lakh under the Head of Account 2810-00-800-78 during the year 2023-24.

As per the Government order read above, Administrative Sanction was accorded for the implementation of the Projects "ANERT as Knowledge Hub - Technology development / demonstration and Training" for Rs.917.00 lakh under the head of account 2810-00-800-90-(08)-35-00 and "Green Energy Hub" for Rs.92.00 Lakh under the head of account 2810-00-800-78.

3. As per the letter read above, the Chief Executive Officer, ANERT has requested to allocate an amount of Rs.917.00 Lakh under the head of account 2810-00-800-90-(08)-35-00 and an amount of Rs.92.00 Lakh under the head of account 2810-00-800-78 in BAMS.

Government have examined the matter in detail and are pleased to release an amount of Rs.100 Lakh (Rupees Hundred Lakh only) under the head of account 2810-00-800-90-(08)-35 PV and an amount of Rs.25 Lakh (Rupees Twenty five Lakh only) under the head of account 2810-00-800-78 PV to ANERT as I<sup>st</sup> installment from the current years budget allocation, subject to the following usual terms and conditions of fund release.

(i) The amount released shall be transfer credited to PSTSB account in compliance of G.O (P) 62/2018/Fin dated 16/04/2018.

(ii) The instructions in Circular No.84/2008/Fin dated 09/12/2008, Circular No.8/2018/Fin dated 30/01/18 & G.O(MS) No.93/2020/Fin dated 11.09.2020 shall be scrupulously followed.

- (iii) The Chief Executive Officer, ANERT shall furnish duly authenticated detailed component wise statement of expenditure and Utilization Certificate as per instructions in G.O(MS)No. 4/2020/Fin dated 09/01/2020.
- (iv) If there is unutilized amount at the end of this financial year that should be refunded to the Government during the financial year itself.
