**ORDER**

The State Police Chief, as per the letter read above, has reported that newly formed Cyber Division is under the direct supervision of Inspector General of Police (Cyber Operations) and it comprises of two wings,viz (A) Telecommunication and Technology (B) Cyber Operations, each under a superintendent of Police. The existing Telecommunication wing, excluding the posts shifted to Cyber Division HQ, Cyber Police Stations and Cyber Patrol, becomes the Telecommunication and Technology wing and the wing is headed by SP (Telecommunication and Technology). The Cyber Operation Wing, headed by Superintendent of Police (Cyber Operations) have two sub units, viz. (a). Cyber Operation Unit and (b) Research and analysis Unit, each headed by a DySP. The administrative control of the Cyber Division Headquarters comprising of the Telecommunication and Technology wing, Cyber Operation wing (both ministerial and executive) is vested with Inspector General Police cyber Operations. The existing administrative office of erstwhile Telecommunication HQ becomes the Office of the Cyber Headquarters. This Office also cater to all administrative affairs of both the Technology & Communication wing and the Cyber Operation wing.

2. The State Police Chief has proposed to change the nomenclature of the Telecommunication Headquarters as 'The Office of Inspector General of Police, Cyber Operations' for administrative convenience to cope with the existing strength.

3. Government have examined the matter in detail and concurs with the

views of the State Police Chief in this regard. Therefore, the nomenclature 'Telecommunications Headquarters' is hereby changed to 'Office of the Inspector General (Cyber Operations)'
