ORDER

As per letter read as 1st paper above the District Collector, Malappuram has reported that during monsoon 2019 a landslide occurred in Kottakkunnu in Malappuram district and 3 people lost their lives. It has been reported that since then, the local residents are being shifted temporarily to safer places during the heavy rains.

2) The District Disaster Management Authority, Malappuram has recommended the construction of a proper drainage system to safely drain the rain water accumulated on the top of the hill to the streams below after conducting a contour survey to demarcate the boundaries in the area. The District Collector has reported that the land had been surveyed and based on the estimate an amount of Rs. 2.03 crores is needed to complete the project. The District Collector has also requested necessary administrative sanction and funds for the above mitigation work.

3) As per letter read as 2nd paper, the Commissioner, Disaster Management has reported that funds for the construction of drainage

system to avoid possible landslides in Kottakkunnu can be sanctioned from State Disaster Mitigation Fund (SDMF) with the approval of the State Executive Committee (SEC) of Kerala State Disaster Management Authority (KSDMA).

4) As per the minutes read as 4rd paper above, the State Executive Committee has approved the proposal to release an amount of Rs. 2.03 crores to the District Collector, Malappuram from SDMF for constructing drainage system to safely drain the rain water accumulated on the top of the hill to the streams below after conducting a contour survey to demarcate the boundaries in the area in Kottakkunnu.

5) Government have examined the matter in detail and are pleased to accord sanction to release an amount of Rs. 2.03 crores to the District Collector, Malappuram from SDMF for constructing a drainage system after conducting a contour survey to demarcate the boundaries in the area in Kottakkunnu.
