**ORDER**

The Project Director, PMU-KRFB, Thiruvananthapuram as per letter read as 3rd paper above has requested sanction for the acquisition of 3.65 Ares of land in Purathur Village of Malappuram district for the widening of existing road connecting Nayathodu bridge & Coastal Highway as detailed below:

2. Government have examined the matter in detail and are pleased to accord sanction to the District Collector, Malappuram to acquire an extent of 3.65 Ares of land in Purathur Village for the widening of existing road connecting Nayathodu bridge & Coastal Highway by invoking the provisions contained in LARR Act, 2013.

3. The District Collector, Malappuram district is to resort to acquire land by invoking the provisions contained in LARR Act, 2013. The District Collector will ensure that approval under extant Acts & Rules viz, Conservation of Paddy land and Wet land Act, Coastal Zone Regulation Act and Environment Act, whichever are applicable to the proposal in this case are obtained by the Requisitioning Authority.

4. The District Collector shall ensure that the requisitioning authority has deposited 5% Contingency Charges of the cost of compensation or Rupees Fifty lakhs whichever is less as provided in Rule 4(3) of LARR Rules, 2015 r/w G.O(P) No17/18/RD dated 12/04/2018, in the TSB account before proceeding with the land acquisition. Before issuance of 19(1) Declaration the District Collector should also ensure that the balance entire cost of compensation of Malappuram district calculated by the Land Acquisition Officer as provided in Rule 4(6) of LARR Rules, 2015 has been fully deposited by the requisitioning authority in the TSB account or else the acquisition proceedings will be stopped at once.
