## **ORDER**

As per the Government Order read as 1<sup>st</sup> paper above, administrative sanction was accorded for the purchase of 5 Numbers of Marine Diesel Engine with Gear Box for an amount of Rs.53,00,000/-(Rupees Fifty Three Lakh Only) by meeting the expenditure from the Head of Account '5056-00-104-99-Purchase of New Engines and Reconstruction of Old Boats (Plan)'.

2) The Director, State Water Transport Department has informed as per letter read 2 <sup>nd</sup> above that the Technical Committee examined the tenders received from two firms namely M/S Techno Tradings & Services (P) Ltd, Kochi and M/S Techno Marine (P) Ltd., Kochi and recommended to accept the lowest tender of M/S Techno Tradings & Services (P) Ltd, Kochi with the following rate:

Rate: Rs.54,50,000/-(Including GST)

3) The Departmental Purchase Committee held on 16/09/2023 examined the proposal and accepted the tender for the purchase of 5 Numbers of Marine Diesel Engine with Gear Box for Rs.54,50,000/-(Including GST) subject to revised Administrative Sanction for

enhanced GST from M/S Techno Tradings & Services (P) Ltd, Kochi.

- 4) Government have examined the matter in detail and are pleased to accord sanction for the acceptance of tender for the purchase of 5 Nos. of Marine Diesel Engine with Gear Box for Rs.54,50,000/- (Rupees Fifty Four Lakh and Fifty Thousand Only) including GST subject to revised Administrative Sanction for enhanced GST from M/S Techno Tradings & Services (P) Ltd, Kochi by meeting the expenditure under the Head of Account '5056-00-104-99-Purchase of New Engines and Reconstruction of Old Boats (Plan)'.
