ORDER

As per the Government Order read as 1st paper above, administrative sanction was accorded for the purchase of 2 numbers of 80 Pax Solar Boat for an amount of Rs.9,40,00,000/-(Rupees Nine Crore Forty lakh Only) by meeting the expenditure from the Head of Account' 5056-00-104-98- Acquisition of Augmentation of Ferry Services (Plan)'.

2) The Director, State Water Transport Department has informed as per letter read 2nd above that the Technical Committee examined the tenders received from two firms namely M/s. Navalt Solar & Electric Boats (P) Limited, Kochi and M/s.Mat Prop Technical Service (P) Ltd, Kochi and recommended to accept the lowest tender of M/s. Mat Prop Technical Service (P) Ltd, Kochi with the following rate:

Rate - 9,39,60,000/- for two number of boats AMC-23,00,000/- per boat per year
