### ORDER

As per the letter read as 3rd paper above, the Government of India have released the first installment of funds, under **RKVY 2023-24 bunch including PKVY BPKP scheme** amounting to ₹71 lakhs as Central share (60%) under SCP category. The category wise split up of funds including State share is as follows:

2. Accordingly, the Director of Agriculture as per the letter read as 4th paper above has requested sanction for the release of ₹118.33333

lakhs (Rupees One Crore Eighteen Lakhs Thirty Three Thousand Three Hundred and Thirty Three Only) as the first installment. The fund released is for implementation of Annual Action Plan under PKVY-BPKP component SCP category for the year 2023-24 approved by the State Level Sanctioning Committee. As per the Government Order read as 5th paper above, additional authorisation to the tune of ₹118.34 lakh is authorised to facilitate the release of the first installment of funds under the scheme PKVY- BPKP for the financial year 2023-24.

3. Government have examined the matter in detail and are pleased to accord sanction to release the *first installment* of fund to the tune of **₹1,18,34,000/-** (One Crore Eighteen Lakh Thirty Four Thousand Only) for releasing the Central share and State share of the scheme PKVY-BPKP (SCP category) for 2023-24 for the following heads.

2401-00-789-83-01 - ₹. 71 lakhs

2401-00-789-83-02 - ₹. 47.34 lakhs

4. The Director of Agriculture Development and Farmers' Welfare is authorised to draw and disburse the amount to the designated Implementing Agency for the purpose , subject to the condition that the amount earmarked for SCP components will be spent exclusively for the respective category of beneficiaries.

5. The Director of Agriculture shall also take timely steps to regularise this additional expenditure within the Grant through Re-appropriation of Savings only within the Grant before the close of the current financial year.

6. The Director of Agriculture Development and Farmers' Welfare Department after completion of the financial year should prepare a reconciled Statement of Expenditure (SoE) and furnish the same to Accountant General (Audit) as stipulated in Government Order read as 1st paper and Circular read as 2nd paper above.
