### ORDER

Vide Government Order read 1<sup>st</sup> above, Administrative Sanction for meeting the expenditure towards the Acquisition of 14.5 acres of land from Pallickal Village (7 acres) and Nediyruppu Village (7.5 acres) for the development of RESA at both ends of the Calicut International Airport at a total cost of ₹71,15,20,000/- (Rupees Seventy One Crore Fifteen Lakh Twenty Thousand Only), from the Head of account 5053-02-190-93-Land Acquisition for the Development of Kozhikode Airport (Plan-Voted) was issued and also ordered to release Rs. 71,15,2000/-. Then, as per Government Order 2<sup>nd</sup> paper above the amount to be released as first installment was modified to ₹18,25,000,00/- (Rupees eighteen Crore twenty five lakh only) and subsequently released the amount.

2) Vide letter referred 3<sup>rd</sup>, the District Collector, Malappuram has requested to release an amount of ₹ 25 Cr and Contingency Charge of ₹ 25 Lakh towards the acquisition of land for the development of RESA at the Calicut International Airport and to deposit the releasing amount to the account of Special Deputy Collector, Land Acquisition (Kozhikkode Airport) by cross-mapping the DDO Code 151061B030.



3) Government examined the proposal in detail and are pleased to release an amount of ₹25,25,000,00/- (Rupees Twenty Five Crore Twenty Five lakh only) as the second installment of Land Acquisition and as Contingency Charge to the Special Deputy Collector, Land Acquisition (Kozhikkode Airport) for the above purpose by enhancing the ceiling limit to 61.49% under the head of account 5053-02-190-93-Land Acquisition for the Development of Kozhikkode Airport (Plan-Voted).
