ORDER

The Chief Engineer (I&A), vide his letter read as (1) above, has forwarded the proposal of fourteen side protection works of various ponds in Nemom LA constituency for according administration sanction for an amount of Rs. 4,00,00,000/- (four hundred lakhs only). The Chief Engineer (I&A) reported that the subject works are included in the budget 2023–24 Annexure II (Sl. No. 1124) with an allocation of 20% of the total amount, i.e., Rs. 80,00,000/- (eighty lakhs). The estimate submitted by CE (I&A) for the proposed 14 works (side protection works of various ponds) amounting to Rs. 400 lakhs in Nemom LA Constituency is as follows:
