ORDER

As per Government Order read as 1st paper above, Government have constituted a three member Waqf Tribunal with headquarters at Kozhikode. As per the Government Order read as 2nd paper above, Government had appointed Advocate T.K.Hassan as non-judicial member of the Waqf Tribunal for a term of five years along with other members. He joined the service on 19.01.2019 and hence his term of appointment expired on 18.01.2024.

2] As per the letter read as 3^d paper above, the Chairman, Waqf Tribunal has forwarded the application submitted by Sri.T.K.Hassan, the former Member of the Waqf Tribunal, for terminal surrender of earned leave for 60 days.

3] Government have examined the matter in detail. As per Rule 2 of Appendix VIII of KSR Part I, when the appointment is for more than one year but not more than five years, the earned leave will be admissible at 1/11 of the period spent on duty, subject to a maximum of 15 days in a year. Such leave can be accumulated up to a maximum period of two months. Therefore earned leave admissible to Sri. T K Hassan is required to be calculated on the basis of the said rules and his terminal surrender to be allowed diminishing the EL already availed/periodically surrendered.

4] In the above circumstances, Government are pleased to sanction terminal surrender of earned leave to Sri.T.K.Hassan, the former Member of the Waqf Tribunal, Kozhikkode, for a maximum period of 60 days as on 18.01.2024, subject to the conditions stipulated in Rule 2 of Appendix VIII of KSR Part I.
