ORDER

As per Government order read as second paper above, Government have created an Ex-cadre post of Additional Commissioner (the post of Joint Commissioner is re-designated as Additional Commissioner) and appointed Sri.Abraham Renn. S (C&CE 2013) IRS, Central Board of Indirect Tax and Customs in State Goods and Services Tax Department, in pay band of Rs. 69700-208700 and pay matrix level of 11, on deputation basis for a period of 3 years in the newly created post on the condition that the appointment on

deputation basis will be governed by the terms and conditions prevailing in the state.

As per the letter read as 3rd paper above Sri.Abraham Renn S IRS have expressed his willingness to extend the deputation with the State GST Department and has requested to take further steps with the office of the Chairman, Central Board of Indirect Taxes and Customs (CBIC), Department of Revenue, Ministry of Finance to extend his deputation to Government of Kerala for a further period of two years.

As per the letter read as 4th paper above, Government of India, have conveyed the cadre clearance in respect of Sri.Abraham Renn S, IRS(C&IT 2013) Additional Commissioner, State Goods and Service Tax Department, Kerala for extension of his deputation tenure with Government of Kerala for a further period of two years w.e.f. .05.08.2023 on deputation basis.
