Home Department – Police Department – Annual Plan 2023-24 – Strengthening Intelligence Set-up - Purchase of Hand Held Metal Detectors (HHMD) - Revised Administrative Sanction accorded - Orders issued.

ORDER

Government have accorded administrative sanction to implement various schemes/activities under the State Plan Scheme 2023-24 and earmarked an amount of Rs.130 Lakh for the implementation of the Scheme "Strengthening Intelligence Set-Up" and out of this an amount of Rs.90 Lakh has been provided for the procurement of various security equipment under the Head of Account "2055-00-115-98-32" for implementing the scheme as per Government Orders read above. The State Police Chief as per letter read above has informed that only one Non Linear Junction Detectors (NLJDs) could be purchased out of Rs. 18,00,000/- instead of 02 Nos. of NLJDs sanctioned. An amount of Rs.15,00,000/- is needed for the same and as such a balance of Rs. 3 Lakhs left as savings.

2) Further it is reported that, only 16 Nos. of Hand Held Metal Detectors (HHMDs) could be purchased within the sanctioned outlay of Rs.7,17,440/- instead of 19 Nos. sanctioned for intelligence security. The State Police Chief has suggested that, the balance amount of Rs.3Lakh which was left after procured the NLJD may be utilized for the purchase of HHMDs in the appropriate specification so as to procure the maximum quantity of HHMDs for intelligence security. Therefore it is requested to accord revised sanction to utilise the amount of Rs. 3Lakh left as balance, for procuring maximum quantity of

HHMDs which are inevitable for intelligence security.

- 3) Government have examined the matter in detail and are pleased to accord revised administrative sanction for the purchase of the remaining three HHMDs out of the sanctioned 19 Nos. by utilizing the savings from the purchase of NLJDs under the Scheme for Strengthening Intelligence Set up, subject to the condition that the quantity of HHMDs as per the Government Order read as 2nd paper above remains unchanged.
- 4) The Government Orders read above stands modified to the above extent only.
