In the annual plan budget 2024-25, a total amount of Rs.600 lakh is provided for implementation of the Plan Scheme 'District Mental Health Programmes' under the head of account '2210-01-110-40(Plan)' as follows:

As per the letter read above, the Director of Health Services has Administrative submitted proposal seeking Sanction implementation of the Plan Scheme 'District Mental Programmes' for a total amount of Rs.550 Lakh, by meeting the expenditure under the head of account '2210-01-110-40(Plan)' from the budget provision for the Financial Year 2024-25. The proposed amount for Administrative Sanction under 34 OC is Rs.4,65,84,275/-, which is more than the corresponding budget provision. Also the proposed amount for Administrative Sanction under 97 HCMV is Rs.84,15,725/which also exceeds the corresponding budget provision. Accordingly, a total amount of Rs.50,00,000/- is proposed to be re-appropriated from HEALTH-P3/87/2024-HEALTH G.O.(Rt)No.1386/2024/H&FV
