ORDER

As per Government Order read as 1st paper above, Administrative Sanction was accorded for the work Kuttur-Peramangalam Road-B/W 2021-22- Improvement of Kuttur-Peramangalam Road with BM and BC - Ch from 0/000 to 1/810 for an amount of Rs.230 lakh.

2. As per letter read as 2nd paper above Chief Engineer (Roads) has informed that based on the present rate of GST and addition of extra items the estimate amount comes to Rs.380 lakh/- and has requested to accord Revised Administrative Sanction for the work for the said amount.

3. Government have examined the matter in detail and are pleased to accord Revised Administrative Sanction for the work Kuttur-Peramangalam Road-B/W 2021-22- Improvement of Kuttur-Peramangalam Road with BM and BC - Ch from 0/000 to 1/810 for an amount of Rs.380 lakh/- (Rupees Three crore Eighty Lakh Only) under the Head of Account 5054-04- 337-99 subject to the following conditions.

1. The provisions of shoulder concreting including its width should be reviewed and it should be provided at essential locations only.
2. The departmental rubble available at site should be properly accounted and only balance quantity should be brought from outside ascertained

- by the Agreement authority.
3. GI pipe railing is seen proposed at one side of the road and its essentially should be ensured by the TS authority.
 4. The Work Intimation Reports to CTE shall be accompanied by a covering letter for this Work.
 5. The rates, provisions, quantities should be verified and confirmed by the TS authority while approving RE and a copy of approved RE should be forwarded to the Government for compliance.
