Government have examined the matter in detail and are pleased to accord Administrative Sanction for the above 7 works for an amount of Rs.167 crore (Rupees One hundred and sixty seven crore only) under the head of account 5054-05-101-99(P), under SETU BANDHAN Scheme under Central Road infrastructure Fund(CRIF) during the financial year 2022-23, subject to the following conditions:

- (i) The above works shall be awarded only after Land Acquisition and shifting of utilities, if any .
- (ii) The expenditure for Land Acquisition and shifting of utilities shall be met from the State share. Proposals for administrative sanction for Land Acquisition if any, shall be furnished to Government in the above works.
- (iii) The Chief Engineer shall strictly follow the CRIF guidelines ensuring no additional commitment to State Government.
- (iv) The Chief Engineer shall strictly follow the guidelines in the letter read as 1st paper above.

As the work "Construction of Cherayakkode Bridge across Olippuzha at Edappatta Gramapanchayath in Manjeri LAC in Malappuram District-Bridge proper and Approach Road" has also been included under CRIF Scheme, the Government Order sanctioning the above said work vide G.O read as 2nd above stands cancelled.
