ORDER

Dr. Vishwas Mehta IAS, former Chief Information Commissioner as per DO letter read as first paper above had requested to sanction for surrendering Earned Leave/Half Pay Leave as per his eligibility on completion of his tenure on 29.02.2024.

The Principal Accountant General (A&E), as per letter read as second paper above informed that Dr. Vishwas Mehta IAS was authorised 300 days of Terminal Leave (291 EL + 09 HPL) as of 28.02.2021 and also that acquiring Earned Leave during re-employment period in State Information Commission, in place of the HPL component of 09 days, he is eligible for 09 days of Earned Leave itself, thus making him eligible for a total of Terminal Surrender of Earned Leave for 300 days as on 29.02.2024, after deducting the amount already disbursed to him as on 28.02.2021.

Dr. Vishwas Mehta IAS was sanctioned 291 days of Earned Leave and 9 days of HPL as Terminal Surrender, and a total of Rs. 28,36,800/- (Rupees Twenty Eight Lakh Thirty Six Thousand and Eight Hundred Only) was sanctioned to him. The Earned Leave Surrender of 9 days will amount to $(225000 + 63000) \times \frac{9}{30} =$ Rs. 86400/- (Rupees Eighty Six Thousand Four Hundred Only) . An amount of Rs. 43200/- (Rupees Forty Three Thousand and Two Hundred Only) has already been paid as Half Pay Leave surrender to him.

Under the circumstances, Government are pleased to sanction Rs. 43200/- (Rupees Forty Three Thousand and Two Hundred Only) as Earned Leave Surrender to Sri. Vishwas Mehta IAS. for his tenure as Chief Information Commissioner.


