ORDER

As per the Government Order read as 1 st paper above, sanction was accorded to release an amount of Rs.12.73 crore to the Kerala State IT Infrastructure Limited (KSITIL) from the budget allocation for the Financial Year 2022-23 for Skill Delivery Platform Kerala (SDPK) project by debiting the expenditure from the Head of Account 4859-02-190-94(02). The Managing Director, KSITIL, as per the letters read as 2nd paper above, informed that an amount of Rs.7,39,68,238/- (Rupees Seven Crore Thirty Nine Lakh Sixty Eight Thousand Two Hundred and Thirty Eight Only) was resumed from the PSTSB account on 31.03.2023 and has requested to release this amount for the SDPK project.

2) Having examined the matter in detail, the Government are pleased to accord sanction for the release of an amount of Rs.3,40,00000/- (Rupees Three Crore and Forty Lakh Only) to KSITIL, from the budget provision for 2023-24, for Skill Delivery Platform Kerala (SDPK) project by debiting the expenditure from the Head of Account 4859-02-190-94(02) subject to the following conditions:-

i) The amount shall be transfer credited to PSTSB account in compliance of the Government Orders read as 3^{rd} to 5^{th} papers above and the Circular read as 6^{th} paper above.

ii) Funds shall be utilized for the purpose for which it is released and shall not be diverted for any other purposes.

iii) The procedures prescribed in the Circulars read as 7 th and 8th papers above should be scrupulously followed.

iv) Financial rules and procedures as specified in the Codal provisions should be strictly observed.

v) The Utilisation Certificate/ Component wise expenditure in respect of the fund released during the previous and current financial years should be furnished in the prescribed proforma appended with the Government Order read as 9 th paper above.

3) The Under Secretary (E&ITD) shall draw the amount and transfer credit the same in favour of the Managing Director, KSITIL in the PSTSB Account No.799012700000582 maintained at the District Treasury, Thiruvananthapuram, which shall be drawn according to actual requirement only.
