ORDER

As per the Government Orders read as 1st paper above, one time

financial assistance amounting to ₹2000 lakhs was sanctioned for restructuring IIITM-K to Digital University Kerala in the financial year 2021-22, and an amount of ₹1000 lakhs was released as first installment and the full amount was utilized. The balance amount from the Head of Account 4859-02-190-90 (P) was posted to ELAMS at the end of that financial year.

2) An amount of ₹4,80,00,000/- (Rupees Four Crore Eighty Lakhs Only) was released as per the G.O read as 4th paper above during 2022-23. The amount was fully utilized. Sanction was also accorded for the release of an amount of ₹5,20,00,000/- (Rupees Five Crore Twenty Lakhs Only) as per G.O read as 5th paper above, during 2022-23. However an amount of ₹4,70,42,074/- (Rupees Four Crore Seventy Lakhs Forty two Thousand seventy four only) was resumed from the PSTSB account of Digital University Kerala on 31st March 2023.

3) The Registrar, KUDSIT as per letter read above, has requested to release the resumed fund for effecting payment towards setting up of labs in roof space and procurement of items for the augmentation of schools.

4) Government have examined the matter in detail and are pleased to release an amount of ₹470.43 lakh (Four Crore Seventy Lakh Forty Three Thousand only) to KUDSIT by debiting the expenditure under the head of account **4859-02-190-90 (P)** as one time financial assistance for restructuring of IIITM-K into a Digital University subject to the conditions mentioned below:

i) The amount shall be transfer credited to PSTSB Account in compliance with Government order read as 7th paper above.

ii) Funds shall be utilised for the purpose for which it is released and not diverted for any other purpose.

iii) The procedures prescribed in the Circulars read as 8th, 9th and 10th papers above, and Government Orders read as 11th and 12th papers above should be followed strictly and the amount that can be spent during the current Financial

Year only shall be drawn.

iv) The Utilisation Certificate for the whole amount released should be furnished to Government in due course in the prescribed proforma as appended with Government Order read as 13th paper above.

v) The filing fee for ROC and other connected expenditure arising due to enhancement of the authorised capital shall be met by the company from its internal resources and Government will not provide any fund on this.

5) The Under Secretary(E&ITD) shall draw the amount and transfer credit the same in favour of Digital University Kerala in the PSTSB Account No:799012700002180 maintained at the District Treasury, Thiruvananthapuram, which shall be drawn according to actual requirement only.
